

## Additional CTR Exam Testing Dates and Other Exciting Enhancements Coming in 2014

NCRA Council on Certification has added a third testing window and extended the testing periods from two to three weeks. The increased testing windows are in response to CoC Standard 5.1, which require that beginning January 1, 2015, all cancer registry staff who perform case abstracting at a CoC accredited program hold a current Certified Tumor Registrar (CTR®) credential. The Council is also working with new testing company in 2014: AMP or Applied Measurement Professionals, Inc.

These logistical changes coincide with content updates to the 2014 exam, including updating the exam content outline and weighting, plus reducing the number of exam questions (from 250 to 225). In addition, candidates will have a total of four hours to take the exam, with a maximum of 2.5 hours allotted for the closed-book section and 1.5 hours for the open-book section.

## 2014 CTR Exam Dates

Testing Period: March 8 – 29 (Application Deadline: January 31) Testing Period: June 21 – July 12 (Application Deadline: May 2) Testing Period: Oct. 18 – November 8 (Application Deadline: September 19)
